**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
SENEKER & ASSOCIATES, LLC**

1. **The Entity Name.** The name of the limited liability company is Seneker & Associates, LLC. (the "Company"). The entity's date of organization is January 11, 2002.
