ARTICLES OF ORGANIZATION
of

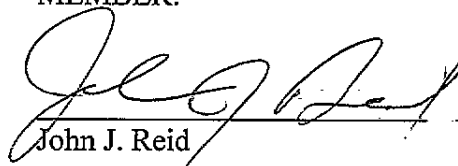

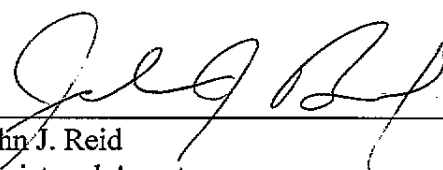
