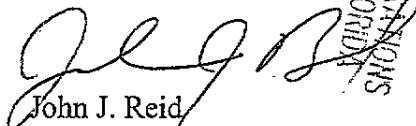

**ARTICLES OF ORGANIZATION**  
of  
**LAGO REAL, LLC**  
a Florida limited liability company

**ARTICLE I**  
**NAME**

The Company shall initially be managed by the following persons who shall serve as managers until the first annual meeting of the members or until their successors are elected and qualify:

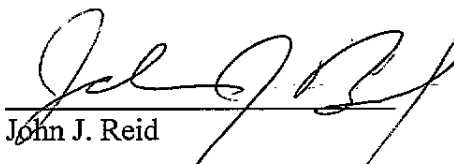
