**ARTICLES OF AMENDMENT

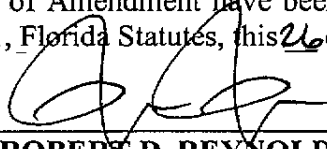

SIXTH: Article V of the Articles of Organization, as amended, provides as follows:

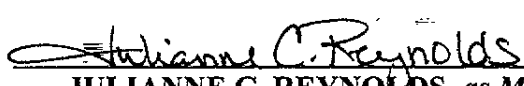
