**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
Name**

The name of the limited liability company ("Company") is WIRTH COLEMAN LAND COMPANY, LLC.

Termination of Business

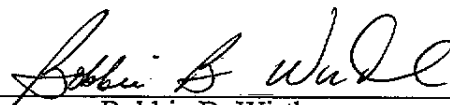
