A LIMITED LIABILITY COMPANY

1. NAME. The name of the limited liability company is SHAW'S TREE SERVICE, LLC.
2. PURPOSE. The purpose of this limited liability company is the transaction of any and all lawful business for which limited liability companies may be organized in the State of Florida
