**ARTICLES OF ORGANIZATION FOR  
ALLERTON AND ASSOCIATES, L.L.C.,  
a FLORIDA LIMITED LIABILITY COMPANY**

The undersigned member or authorized representative of a member pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

**ARTICLE I - Name:**

The name of the Limited Liability Company is ALLERTON AND ASSOCIATES, L.L.C.

**ARTICLE II - Address:**

The mailing address and street address of the principal office of the Limited Liability Company is 545 Karen Avenue, Altamonte Springs, Florida 32701.

**ARTICLE III - Duration:**


