

The address of company's principal place of business and mailing address in Florida is 4881 Northwest 8th Avenue, Suite 201, Gainesville, Florida 32605.



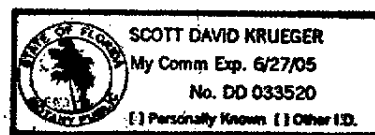
