**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
PENSACOLAHOME.COM, LLC
(A Florida Limited Liability Company)**

The undersigned authorized representative of a member, which member is duly licensed to practice as a real estate broker under the laws of the state of Florida, adopts these articles of amendment in order to form a professional limited liability company under the Professional Service Corporation and Limited Liability Company Act, chapter 621, Florida Statutes.

- FIRST: The name of the company is: PensacolaHome.com, LLC
- SECOND: The date of filing of the articles of organization was January 16, 2002.
- THIRD: The following amendment to the articles of organization was adopted by the limited liability company:

ARTICLE I- NAME

The name of the company is Bill Sheffield, P.L.


ARTICLE VII - PURPOSE

The professional limited liability company is formed to engage in every phase and aspect of the practice of a real estate broker. In addition, the professional limited liability company may invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE VIII - RESTRICTION ON MEMBERS

None of the membership interests of the professional limited liability company may be issued to anyone other than an individual duly licensed to practice as a real estate broker in the state of Florida. No member of the professional limited liability company may sell or transfer a membership interest therein except to another individual who is eligible to be a member of the professional limited liability company. If any member becomes legally disqualified to practice as a real estate broker in the state of Florida, is elected to a public office, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, that member's interest shall immediately become subject to purchase by the professional limited liability company in accordance with the operating agreement.
