**CERTIFICATE OF AMENDMENT OF ARTICLES OF ORGANIZATION**  
**OF VALJOR INVESTMENT GROUP III, L.L.C.**

Jorge A. Valdes, member of VALJOR INVESTMENT GROUP III, LLC, a Florida limited liability company, (the "Limited Liability Company"), hereby certifies that all of the Members of the Limited Liability Company adopted a resolution by unanimous written consent on the 22<sup>nd</sup> day of January, 2002, which approved and adopted the following amendment to the Limited Liability Company's Articles of Organization filed on January 17, 2002:

**"ARTICLE III**  
**CAPITAL CONTRIBUTIONS**

Capital contributions in the amount of One Thousand and 00/100 Dollars (\$1,000.00) cash shall be paid to the limited liability company by the members as follows:

The distributive share of the profits shall be determined and paid to the members on the anniversary date of the commencement of business of the limited liability company.

2. Losses. All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business.
