ARTICLE I

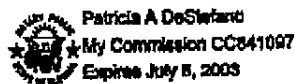


