**ARTICLES OF AMENDMENT OF  
ARTICLES OF ORGANIZATION OF  
LEVENDO, LLC**

The undersigned, for the purpose of amending the Articles of Organization of LEVENDO, LLC, a limited liability company formed and existing under the laws of the State of Florida, adopts the following Articles of Amendment pursuant to Section 608.411, Florida Statutes:

**ARTICLE I - NAME**

The name of this limited liability company is LEVENDO, LLC.

**ARTICLE II - DATE OF FILING OF ARTICLES OF ORGANIZATION**

The Articles of Organization of this limited liability company were filed with the Florida Department of State on January 17, 2002, and assigned document number L02000001399.

**ARTICLE III - AMENDMENT TO ARTICLES**

Article VII of the Articles of Organization is hereby deleted in its entirety and replaced with the following:

**Article VII  
Management**

Section A. Management. The limited liability company is to be manager managed in accordance with the Operating Agreement of the limited liability company, as amended.

**ARTICLE IV - DATE OF ADOPTION**

The foregoing amendments to the Articles of Organization were adopted on the 5th day of January, 2004, by a unanimous vote of the members. The number of votes cast for the amendment was sufficient for approval.
