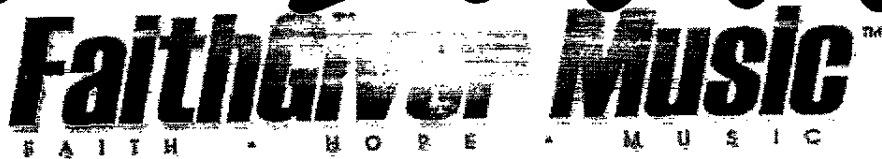


The duration of existence for FaithGiver, LLC., shall be in perpetuity until at such time as the operations of the company are ceased by the will of the members or managers.



#### ARTICLE VII


