ARTICLES OF ORGANIZATION

The Company is to be managed by managers. Each initial manager will serve until the first annual meeting of the members. The initial manager is identified as follows:

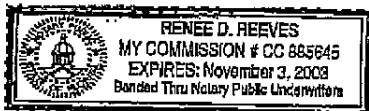


