**ARTICLES OF ORGANIZATION OF
NORTHWEST FLORIDA CONCRETE EQUIPMENT SALES, L.L.C.**

The undersigned, CRAFTSMAN, L.L.C., formerly known as Craftsman Contractors, L.L.C., a Florida limited liability company and entity competent to contract, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

NORTHWEST FLORIDA CONCRETE EQUIPMENT SALES, L.L.C.

This limited liability company is referred to in these Articles of Organization as "the Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act.

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Secretary of State of Florida. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Company is 55 South B Street, Pensacola, Florida 32501, and the name of the registered agent at that address is Patrick Sullivan.

ARTICLE VI - MANAGEMENT

The Company will be managed by its members. The name and address of the entity who is the initial sole member and who shall manage the Company in accordance with the Operating Agreement of the Company are as follows:

ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS

The initial member of the Company is Craftsman, L.L.C. New members may be admitted to the Company only as provided in the Operating Agreement. Contributions required of new members shall be determined as of the time of admission to the Company.

ARTICLE VIII - RESTRICTION ON MEMBERSHIP

A member may not sell or otherwise transfer the member's Membership Interest until the member has complied with the restrictions, including a right of first refusal contained in the Operating Agreement for the Company.

ARTICLE IX - AMENDMENT

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.
