**ARTICLES OF ORGANIZATION OF
NORTHWEST FLORIDA CONCRETE PUMPING, L.L.C.**

The undersigned, CRAFTSMAN, L.L.C., formerly known as Craftsman Contractors, L.L.C., a Florida limited liability company and entity competent to contract, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

NORTHWEST FLORIDA CONCRETE PUMPING, L.L.C.

This limited liability company is referred to in these Articles of Organization as "the Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE V - REGISTERED OFFICE AND AGENT

ARTICLE VI - MANAGEMENT

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.
