**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF EQUAPRIDE, LLC**

The Articles of Organization of EquaPride, LLC, a Florida limited liability company (the "Company"), are amended as set forth in these Articles of Amendment:

1. The name of the Company is EquaPride, LLC.
