The limited liability company is to be managed by one or more managers and is therefore a manager-managed company.

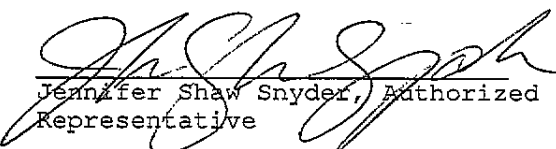
ARTICLE VI. Admission of Additional Members.

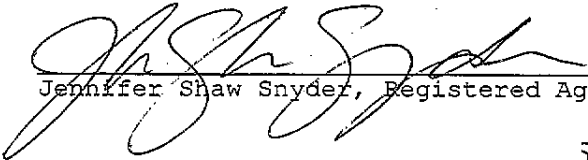
ARTICLE VII. Members Rights to Continue Business.
