FIRST: The name of the limited liability company filing these Articles of Correction is 1931 SERVICES, LLC (the "Company").

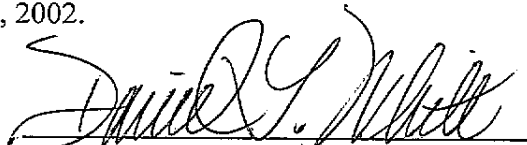

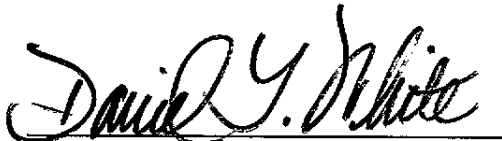

The management of the Company shall be reserved to its members, who shall manage the Company's business and affairs in accordance with the manner set forth in the Company's Operating Agreement.

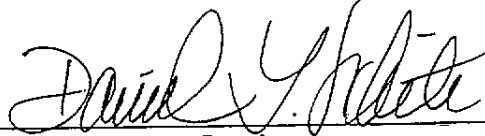
ARTICLE VII: AMENDMENT OF ARTICLES OF ORGANIZATION
