## AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF CARRABELLE BEACH PROPERTIES, LLC

These Amended and Restated Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

#### Article 1 - Name

The name of this limited liability company is CARRABELLE BEACH PROPERTIES, LLC ("Company").

#### Article 2 - Duration
