**ARTICLES OF ORGANIZATION
OF
JKL ASSOCIATES, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, being a natural person of at least 18 years of age, acting as organizer, hereby forms a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, Sections 608.401 *et seq.*, as amended from time to time (the "Act"), and adopts the following Articles of Organization for such limited liability company.

ARTICLE I

Name

The name of the limited liability company is **JKL Associates, LLC** (the "Company").

ARTICLE II

Duration




