ARTICLES OF ORGANIZATION

THE UNDERSIGNED, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Florida Limited Liability Company (the "Company") under the laws of the State of Florida does set forth the following:

1. NAME The name of the Company is:

6. ADMISSION OF ADDITIONAL MEMBERS

Pursuant to Section

608.4232 of the Act, the Company may admit additional members upon the affirmative vote of a majority in interest of the members holding membership interests of the Company, either in attendance at a duly called meeting of the members at which a quorum exists or by written consent of the members of the Company. Only a Class "A" shareholder of Abrams Anton P.A. may become a member of this Limited Liability Company.
