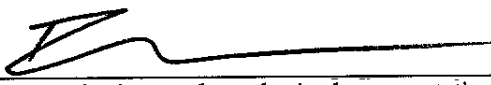
**ARTICLE V – Registered Agent:**

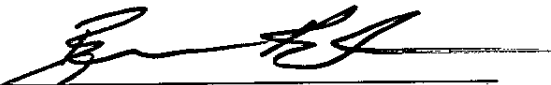
