The name of the limited liability company is: **THE BACK FORTY PROPERTIES GROUP, LLC**

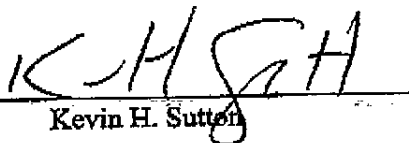
ARTICLE II. ADDRESS
