ARTICLES OF ORGANIZATION

OF

WEBIMPAX, LLC

The undersigned person hereby adopts these Articles of Organization in order to form limited liability company under Chapter 608 of the Florida Statutes.

ARTICLE I - NAME

The name of this limited liability company shall be WebImpax, LLC (the "Company")

ARTICLE II - DURATION
