**ARTICLES OF ORGANIZATION
OF
SOBER LIVING IN DELRAY, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be Sober Living in Delray, (the "Company").

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company shall be 220 S.E. 10 Street, Apt. 301-A, Delray Beach, Florida 33483.

ARTICLE III – DURATION

The Company shall commence its existence on December 21, 2001. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization or the members of the Company shall consent to continue the Company.

ARTICLE IV – REGISTERED OFFICE AND AGENT

A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VIII – TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

ARTICLE IX – MANAGEMENT



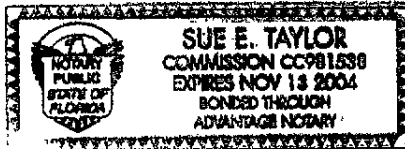


