- SECOND:** Article III of the Articles of Organization of the company shall be amended to be and read as follows:

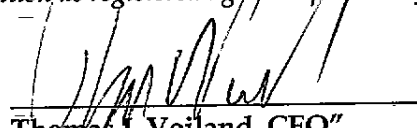
**"ARTICLE III -** The registered Agent, registered office and Registered Agent's signature:

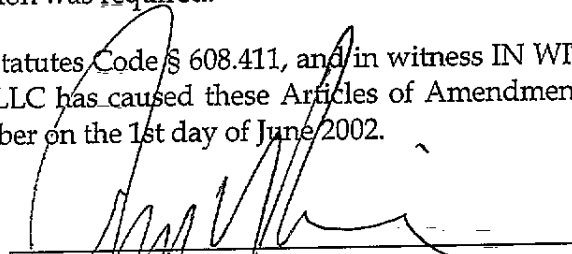
