#### ARTICLES OF ORGANIZATION

These Articles of Organization of a Limited Liability Company under Florida Statutes Chapter 608 (the "Act") are made and entered into as of the 18th day of January, 2002.

- 1. Name. The name of the limited liability company is 4 SIGHT TECHNOLOGIES,
- 2. <u>Duration</u>. The company shall have a duration of thirty (30) years from the date hereof, unless earlier terminated in accordance with Florida Statutes Chapter 608.

- 5. New Members. The members may admit new members upon agreement of the members upon terms determined hereafter by the members.
- 6. <u>Continuation</u>. Upon occurrence of an event listed in Florida Statute 608.407(1)(f), the then existing and/or non-bankrupt members may continue the business of the company, if all agree to do so.
- 7. <u>Management</u>. The company shall be managed by its designated manager, and authorized representative of the member(s), until the first annual meeting of the members or until a successor is elected and qualifies. The designated manager's name and address is as follows:

- 10. Regulations. The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulations and management of the affairs of the company.
- Indemnification. The Company shall indemnify, and advance expenses to, to the fullest extent authorized or permitted by the Act, any person made, or threatened to be made, a party to any action, suit or proceeding by reason of the fact that he is or was a manager or officer of the Company or is or was serving at the request of the Company as a manager or officer of another corporation. Unless otherwise expressly prohibited by the Act, and except as otherwise provided in the foregoing sentence, the Members of the Corporation shall have the sole and exclusive discretion, on such terms and conditions as it shall determine, to indemnify, or advance expenses to, any person made, or threatened to be made, a party to any action, suit, or proceeding by reason of the fact that he is or was an employee or agent of the Company, or is or was serving at the request of the Company as an employee or agent of another corporation, partnership, joint venture, trust or other enterprise. Except for any person who is or was a manager or officer of the Company, or any person who is or was serving at the request of the Company as a manager or officer of another corporation, no employee or agent of the Company may apply for indemnification or advancement of expenses to any court of competent jurisdiction.
- 12. <u>Arbitration</u>. Dispute among members shall be settled by arbitration in Miami, Florida, pursuant to the rules and procedures of the American Arbitration Association.
