**ARTICLES OF ORGANIZATION  
OF  
ComVest America, LLC**

The undersigned, as Organizer, for the purpose of forming a limited liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I – NAME**

The name of the Limited Liability Company shall be ComVest America, LLC hereinafter referred to as the "Company."

**ARTICLE II – ADDRESS**

The mailing address and street address of the principal office of the Company shall initially be 100 E. Sybelia Avenue, Suite 105, Maitland, Florida 32751.

**ARTICLE III – DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these articles of organization.

**ARTICLE IV – BUSINESS PURPOSE**

Section 1. This Company is organized for the purpose of engaging in all lawful businesses permitted to a limited liability company organized under the Florida Company Law.

Section 2. The Company shall have all the powers set forth in the Florida Limited Liability Company Act,

**ARTICLE V – REGISTERED OFFICE AND AGENT**

A member may transfer interest in the Company as set forth in the regulations of the Company, which shall provide for the consent of the other members.

## **ARTICLE IX -- TERMINATION OF EXISTENCE**

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members.

## **ARTICLE X -- MANAGEMENT**




