- FIRST:** The name and address of this corporation is **LEHMAN MOVING & STORAGE, LLC**, 600 N Highway 17-92 Ste 168, Longwood, FL 32750 US.
- SECOND:** The date of the adoption of these Articles of Dissolution is 3 November 2003.
