**ARTICLES OF ORGANIZATION

**ARTICLE I -- NAME**

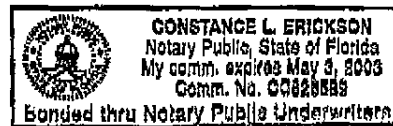
