ARTICLES OF ORGANIZATION
OF

ARTICLE I
NAME

The name of this limited liability company is FARM FRESH INVESTMENT, LLC.

ARTICLE II
DURATION

This limited liability company shall have perpetual existence.

ARTICLE III
PURPOSE
