NAME

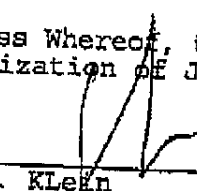

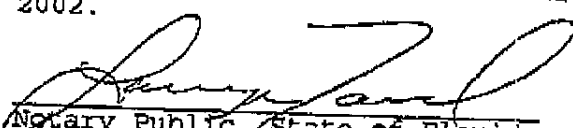

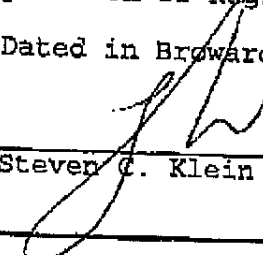
