Articles of Organization
of

a Florida Limited Liability Company

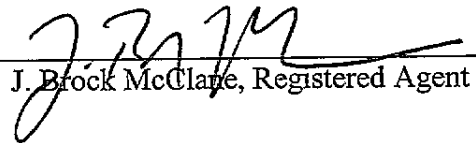
