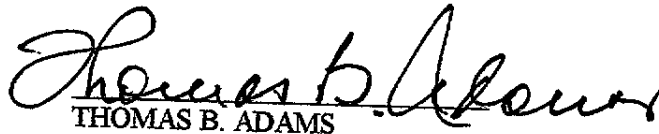

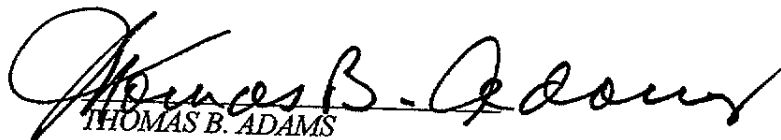

ARTICLE IV - Management

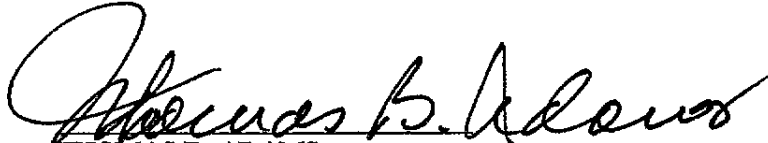
☒ The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager-managed company. The initial manager shall be Thomas B. Adams.
