ARTICLES OF ORGANIZATION
OF
PUPS INVESTMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be PUPS INVESTMENT, LLC (the "Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be One Tampa City Center, Suite 2700, 201 North Franklin Street, Tampa, Florida 33602.

ARTICLE III - DURATION

The Company shall exist from the date of filing these Articles with the Department of State until the earlier of 3 years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - ADDITIONAL MEMBERS

Additional members to the Company may be admitted, but only if all of the current members agree to the admission of the additional members and to the terms of admission.

ARTICLE VI - TERMINATION OF MEMBERSHIP

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.


VII - MANAGEMENT



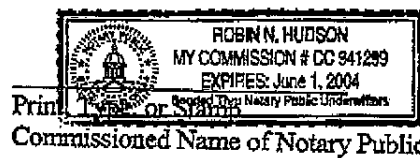


