
ARTICLE VI.

The members shall have the right to do so.

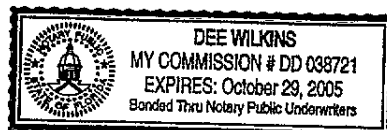
