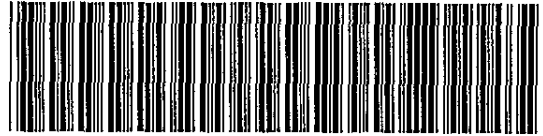



ARTICLE OF AMENDMENT OF BAILEY GRANITE, LLC

THIS IS TO CERTIFY THAT:

First: This article amends the Articles of Organization of Bailey Granite, Limited Liability Company.

Second: The Articles of Organization were filed with the Florida Department of on January 30, 2002.

Third: Article VI of the Articles of Organization previously provided as follows:

The remaining members of the Company have the right to continue the business in the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

The company shall be managed by the members in accordance with Operating Regulations as amended adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization. Fourth: Article VI of the Articles of Organization, as amended, provides as follows:

The business may be continued only on the unanimous written consent of the remaining members.

Fifth: A new Article VII is added as follows:

ARTICLE VII - MANAGEMENT

The Limited Liability Company shall be managed by one or more managers and manager-managed company. The manager shall be elected as provided for in the Operating Agreement. The manager or managers authority is restricted and limited by the Operating Agreement.
