ARTICLES OF ORGANIZATION

ARTICLE I - NAME

The name of the Limited Liability Company is XYZ VENTURE PARTNERS, L.L.C.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is: 6721 Woodbridge Drive, Boca Raton, FL 33434.

ARTICLE III - DURATION

The period of duration for the Limited Liability Company shall be perpetual.

ARTICLE IV - MEMBER UNITS

The remaining members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company, upon the approval of members owning a majority of the issued and outstanding Member Units of the Limited Liability Company. A manager does not have to be a Member of the Limited Liability Company.
