ARTICLES OF ORGANIZATION FOR UCCI DEVELOPMENT COMPANY OF THE PALM BEACHES, LLC

ARTICLE I - Name

The name of the Limited Liability Company is UCCI DEVELOPMENT COMPANY OF THE PALM BEACHES, LLC.

ARTICLE II - Address:
