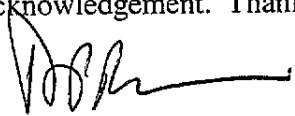

**ARTICLES OF ORGANIZATION
OF
RAYDON INTERNATIONAL, LLC
A Florida Limited Liability Company**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "Raydon International, LLC."

ARTICLE II — Address:

The mailing address and street address of the principal office of the Company is: 210 Fentress Blvd., Daytona Beach, FL 32114.

ARTICLE III — Registered Agent

The name and street address of the initial registered agent is: David P. Donovan, 125 Brookside Dr., Daytona Beach, FL 32124.

ARTICLE IV — Duration:

The Company shall exist until May 1, 2011, but shall be dissolved earlier upon (i) the unanimous written agreement of all Company members (the "Members"), or (ii) the death, insanity, bankruptcy, retirement, resignation, or expulsion of a Member, the occurrence of any other event in accordance with Section 8 of the Limited Liability Company Operating Agreement of Raydon International, LLC, or the occurrence of any other event which terminates the continued membership of a Member in the Company, unless the business of the Company is continued in accordance with the provisions of Article VII below.

ARTICLE V — Management:

The Limited Liability Company is to be managed by a manager or managers and is, therefore, a manager-managed company.

ARTICLE VI — Admission of Additional Members:

Additional Members may be admitted in accordance with the Operating Agreement.

ARTICLE VII — Members' Rights to Continue Business:

Upon the death, insanity, bankruptcy, retirement, resignation, or expulsion of a Member or

upon the occurrence of any other event which terminates the continued membership of a Member in the Company, the Company shall dissolve in accordance with Article IV unless the Company is continued by the consent of the Members.

ARTICLE VIII — Limitation on Agency Authority of Members

Pursuant to Section 608.4235 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

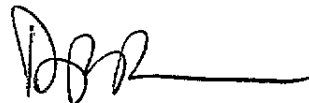
ARTICLE IX — Operating Agreement

Any Operating Agreement, as defined in Section § 608.402(24) of the Act, relating to this Limited Liability Company must be in writing and signed by all of the members.

ARTICLE X

The unanimous consent of all members of the Company is required to alter, amend, repeal, or adopt any provision or provisions inconsistent with these Articles of Organization.

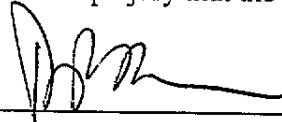
