ARTICLES OF ORGANIZATION OF

RAYDON INTERNATIONAL, LLC

A Florida Limited Liability Company

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "Raydon International, LLC."

ARTICLE II — Address:

The mailing address and street address of the principal office of the Company is: 210 Fentress Blvd., Daytona Beach, FL 32114.

ARTICLE III — Registered Agent

ARTICLE VII — Members' Rights to Continue Business:

Upon the death, insanity, bankruptcy, retirement, resignation, or expulsion of a Member or

upon the occurrence of any other event which terminates the continued membership of a Member in the Company, the Company shall dissolve in accordance with Article IV unless the Company is continued by the consent of the Members.

ARTICLE VIII — Limitation on Agency Authority of Members
