**ARTICLES OF ORGANIZATION
OF
BRIGHT ISLAND, LLC.**

ARTICLE I - NAME

The name of the Limited Liability Company shall be: **Bright Island, LLC.**
("Company")

ARTICLE II - ADDRESS

ARTICLE III - COMMENCEMENT AND TERM OF EXISTENCE

In accordance with Section 608.409(1) of the Florida Limited Liability Company Act (the "Act"), the term of existence of the Company shall commence upon filing, and shall continue perpetually, unless otherwise dissolved pursuant to Article VIII of these Articles of Organization.

ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - ADDITIONAL CONTRIBUTIONS

Each member shall make additional future capital contributions to the Company as provided in the Regulations of the Company or otherwise by the unanimous consent of all members.

ARTICLE VI - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the majority written consent of the members of the Company and on such terms and conditions as shall be determined by said majority members. A member may only transfer his or her interest in the Company as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless the majority of the other members of the Company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by majority written consent.

ARTICLE VII - DISSOLUTION OF COMPANY

Upon the death, insanity, bankruptcy of dissolution of a member or upon the occurrence of any other event provided in the Regulations of the Company or under the Act, the Company shall be dissolved unless the members elect to continue the Company either upon the affirmative vote or written consent of those members owning a majority of the capital and profits of the Company as contemplated in Rev.Proc. 94-46.

ARTICLE VIII - MANAGEMENT

The Company shall be managed by the manager or managers elected or appointed by the members in accordance with the Regulations to be adopted by the members for the management of the business and affairs of the Company. These Regulations may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. The name and Address of the
