The name of the Limited Liability Company is Lake Carroll Plaza, LLC.

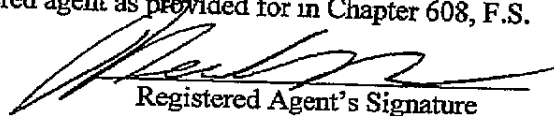

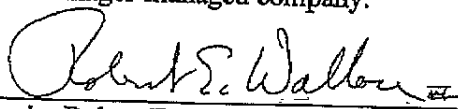
