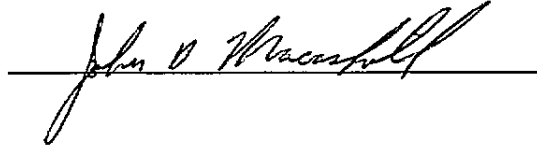

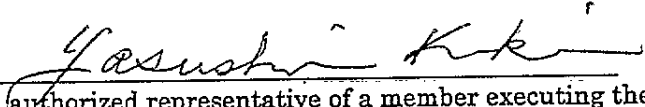
ARTICLE VI – Admission of Additional Members:

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be vested solely in Yasushi Kuki.

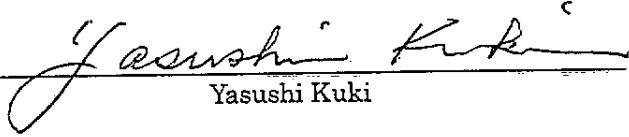
ARTICLE VII – Members' Rights to Continue Business:
