ARTICLES OF ORGANIZATION

RELO PROS MOVING & STORAGE LLC

A LIMITED LIABILITY COMPANY

(Pursuant to s. 608.407, Florida Statutes)

- 1. NAME. The name of the limited liability company is RELO PROS MOVING & STORAGE LLC.
- 2. <u>PURPOSE</u>. The purpose of this limited liability company is the transaction of any and all lawful business for which limited liability companies may be organized in the State of Florida
