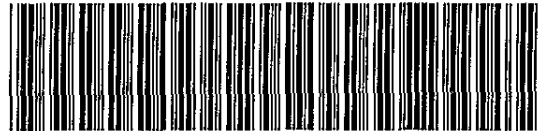

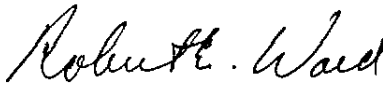

**ARTICLES OF ORGANIZATION**

The undersigned, acting at the direction of and on the behalf of one or more persons desiring to be members of and having agreed to form SPARTAN MASONRY, LLC as a limited liability company pursuant to Section 608.408(3) of the Florida Statutes, as amended from time to time (the "Act"), does hereby acknowledge and certify that:

**ARTICLE ONE**  
**NAME**

The name of the Limited Liability Company (the "Company") is SPARTAN MASONRY, LLC. The Company was organized under the name "Spartan Concrete, LLC" by Articles of Organization filed with the Florida Department of State on February 7, 2002. By Articles of Amendment filed with the Florida Department of State on June 24, 2002, the Company changed its name to "Spartan Masonry, LLC".

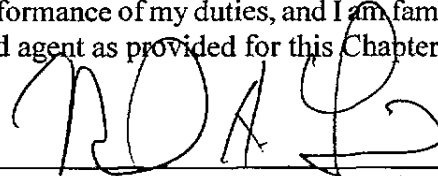

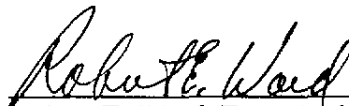
