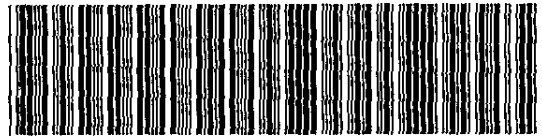


FIRST: The Articles of Organization were filed on February 12, 2002 and assigned document number L02000003526.
