

ARTICLES OF ORGANIZATION OF WIND SOUTH PROPERTIES DEVELOPMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company shall be WIND SOUTH PROPERTIES DEVELOPMENT, LLC. (the "Company").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the Company shall be 11330 S.W. 164th Street, Miami, Florida 33157.

ARTICLE III. PURPOSES AND POWERS

The Company is authorized to transact any business permitted by the laws of the State of Florida for a limited liability company.

ARTICLE IV. DURATION

The Company shall commence its existence on the date that the Articles are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is carlier dissolved as provided in the Operating Agreement.

The Articles may be amended only by the majority consent of the members.
