ARTICLES OF ORGANIZATION

The mailing address and street address of the principle office of the Company is 9371 Old Hickory Circle, Ft. Myers, FL 33919.


ARTICLE III - DURATION

ARTICLE IV - REGISTERED OFFICE AND AGENT

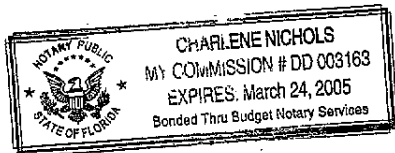


